Doug Driscoll has been a nuisance in the White Springs Area (still considered Columbia County) for almost 6 years. He has harassed and abused children, women, and men several times. Still only being charged with 2 counts of aggravated assault with a deadly weapon, 2 counts of aggravated battery, and shooting into an occupied structure. He is being held on a 50,000 dollar bond. On the afternoon of September 29 2011, this man shot into the Mcglashan's yard 18 times. Amber and Mark Mcglashan were hit 11 times total. Mark's entire bullet wounds were in his backside from running away and Amber's wound was on the front side from her running to her father. Amber's little sisters 14 and 16 years old (one legally blind) were in the yard during the incident. They watched everything!!This is all this man gets charged with and also gets a bond. This petition is for the Columbia County Law Enforcement to be investigated and Doug Driscoll's charges to be under investigation to see why this is all he got charged with.
